### Schedule A

#### Changes regarding references to "General" or "General Meeting of the Committee"

#### 4 Contributions

(a) The Committee may set the annual contribution payable by Members.

(b) The Committee may decide to impose a special levy for a specific programme of action which Members must pay in addition to the normal Member contribution.

(c) Members must pay all contributions and special levies monthly unless decided otherwise by the Committee.

#### 5.4 Casual vacancy

(d) If a casual vacancy occurs and the unexpired portion of the term of Office is less than three years, the vacancy will be filled by the Committee appointing a Financial Member to that Office.

#### 5.6 Meetings of the Committee

(a) Unless otherwise decided by the Committee, the Committee will meet at least once every six months on such day and at such place as the President may, from time to time, determine. Nothing in these rules prevents the Committee from meeting or passing resolutions at, or on the same day as, an Annual General Meeting or Extraordinary General Meeting.

#### Inclusion of new sub-rule 6(ba) regarding General Meetings

#### 6 General Meetings

(ba) If an Annual General Meeting does not deal with the presentation of the audited general purpose financial report, operating report and auditor's report, an Extraordinary General Meeting shall be called for this purpose.

(h) (iii) Except as provided in sub-rules 6(h)(i) and 6(h)(ii), notice of an adjournment of a General Meeting or of the business to be transacted at an adjourned meeting is not required to be given.

#### Inclusion of new sub-rule 14(c) regarding Passing of Resolutions at an AGM

#### 14 Expenses and accounts

(c) The Committee shall, each year, cause to be prepared, and approve, a general purpose financial report and operating report and shall provide a copy of the same, along with the auditor's report referred to in sub-rule 19(e), to the members in accordance with the Act.

#### Inclusion of the descriptor auditor's" in sub-rule 19(e)

#### 19 Auditor

(e) The appointed auditor must inspect and audit the accounting records kept by the Association in relation to each Financial Year and issue an auditor's report for that Financial Year to the Association.
